After rain, fog plays havoc

Kentucky (US): Now that the rain has cleared out, fog has moved in at the PGA Championship.

Thick fog covered Valhalla on Saturday morning, delaying the resumption of the second round and forcing tournament organisers to play three-somes off both nines for the third round.

Xander Schauffele has a one-shot lead over Collin Morikawa after 36 holes, with Masters champion Scottie Scheffler three shots back as he tries to clear his head and get back into a routine following the wildest day of his career.

Scheffler was arrested early on Friday in a pre-dawn incident with Louisville Metro police, who were investigating a fatal traffic accident involving a pedestrian. Traffic was blocked outside the gates when Scheffler tried to ease his way into the club.

Scheffler shot 66 and later said his head was "spinning." Still to be determined was the cut. There was a slim chance it could move to two-under par. Even if it stays at one-under, that sets a record for the lowest cut in PGA Championship history.

Iga rules on Roman clay

Rome: Iga Swiatek beat Aryna Sabalenka 6-2, 6-3 to win her third Italian Open title on Saturday as the Pole came out on top once again in a battle between the top-two in the women's rankings following her Madrid Open triumph earlier this month.

The title was the 21st of Swiatek's career as the world number one sounded out a warning to her rivals ahead of this month's French Open where she is a three-time champion. Swiatek broke Sabalenka twice in the first set.

Job on the line? Xavi doesn't care

Barcelona: Xavi Hernández on Saturday denied a slew of reports in Spanish media outlets that Barcelona's leadership is considering firing the coach for saying that the club's poor finances will impede it from competing with Real Madrid.

"The club has transmitted to me that I should stay calm and continue working with the same motivation and commitment. Nothing has changed," Xavi said at a pre-match news conference.

Almost all the questions he faced were about the speculation in Spain's sports press that club president Joan Laporta was upset with Xavi for having said earlier this week that "the situation is very difficult, above all on the economic level, for us to compete with our top rivals, whether it be Real Madrid or teams in Europe."

The media reports said Laporta is pondering a replacement for Xavi this summer. Xavi insisted on Saturday that he had heard no such thing from the club.

"I don't care where that information is coming from. I have the support of the president and Deco, our sports director," the former Barcelona midfielder said.

Neither Laporta nor the club has made any public statements about the rumours. The club said they had no comment on them.

Even if Barcelona keep Xavi on, it is still an awkward situation for a coach who just three weeks prior had reversed a previous decision made in January to leave the club this summer.

In April, Xavi said that he had changed his mind after his players showed him that they believed in the team's potential and had improved their performances.

Laporta inherited a club mired in debts of more than \$1.4 billion, and football's most expensive payroll, when he returned to run the club for a second time in 2021.

A few months later he brought back fan favourite Xavi, who had been coaching in Qatar, to lead a team rebuild following the exit of Argentine superstar Lionel Messi.

But, with no cash on hand and mounting debts, Laporta had to sell off future television revenues and other club assets, which Laporta dubbed financial "levers," to sign Robert Lewandowski and other players two seasons ago.

With those reinforcements, Xavi guided Barcelona to the Spanish league title last campaign. But, Barcelona have struggled this season and will finish it without any titles.

Xavi's words earlier this week seemed aimed at curbing the expectations of fans used to the club making significant signings in the summer.

The club's wages still exceed the salary cap established by the Spanish league and they are more likely to sell players this off-season than bring in new talent.

Barcelona play Rayo Vallecano on Sunday seeking a win to lock up a second-place finish in the domestic league and secure a spot in the Spanish Super Cup.

Bayern finish third

Sinsheim: Bayern Munich squandered a two-goal lead to slump to a 4-2 loss at Hoffenheim courtesy of a second-half Andrej Kramaric hat-trick in the Bundesliga finale on Saturday, ending a disappointing season in third place as coach Thomas Tuchel bowed out.

Early goals from Mathys Tel and Alphonso Davies saw the Bavarians go 2-0 up.

Hoffenheim, however, pulled a goal back through Germany international Maximilian Beier just two minutes later, with the hosts gradually taking some of the early pace out of the game.

Bayern Leverkusen finished in top spot on 90 points. VfB Stuttgart finished runners-up on 73 with a 4-0 demolition of Borussia Mönchengladbach.

Germany midfielder Aleksandar Pavlovic went off injured. The 20-year-old midfielder appeared to have a right ankle injury and was substituted by Lovro Zvonarek in the 34th minute.

Napoli's European hopes hang by a thread

Florence: Napoli's hopes of playing European football next season were hanging by a thread after they played out a 2-2 draw at Fiorentina in Serie A on Friday.

Napoli took the lead in the eighth minute through defend-

er Amir Rrahmani, who nodded home a corner by Matteo Politano.

Cristiano Biraghi levelled for Fiorentina in the 40th minute from a free-kick, before M'Bala Nzola put the hosts in front two minutes later when he fired a shot into the bottom corner of the net.

Napoli's Khvicha Kvaratskhelia responded with another stunning free-kick early

in the second half to rescue a point for his team.

Eighth-placed Fiorentina, on 54 points and with a game in hand, are five points behind Lazio in seventh. They can still earn a Europa League spot either by leap-frogging the Rome side or by winning the Europa Conference League final on May 29.

Ninth-placed Napoli, on 52 points, still have a slim chance

of making the Europa Conference League playoffs.

The owner of champions Inter Milan warned over the club's stability after failing to reach an agreement with debt holder Oaktree, as a deadline rapidly approaches to repay a multi-million loan.

Chinese conglomerate Suning, which holds a 68.5% stake in Inter Milan, has to hand back roughly \$408 mil-

lion to Oaktree, a US-based investment fund, by the beginning of next week.

"We have been making every attempt with our partner to find an amicable resolution, including multiple paths for Oaktree to achieve a full and immediate financial return," said Inter Milan chairman Steven Zhang in a letter to supporters.
